## Hire Agreement

The hire of equipment is subject to availability.

This Agreement is between Green Dragon Bowmen (hereinafter known as “GDB”) and

---

(hereinafter known as “the Hirer”) relating to the hire of archery equipment for a limited period as outlined below.

1. The hire of equipment shall run from..... for a period of.....month(s);
2. The Hirer shall pay GDB in advance in respect of the hire:
  - The sum of £10 in respect of the first calendar month’s hire;
  - [The sum of £15 in respect of the second calendar month’s hire];\*
  - [The sum of £20 in respect of the third calendar month’s hire].\*

Equipment will not usually be hired for periods longer than three months in aggregate;

3. All the equipment hired remains the property of GDB;
4. Hired equipment shall be returned within 14 days of it being requested by a member of the GDB Committee. If return of the equipment is requested before the hire period is concluded, a pro rata refund of hire fees will normally be payable to the Hirer, based on the date of return of the equipment and the length of hire period remaining;
5. The Hirer hereby undertakes to keep the equipment in a safe place in such a way as to prevent death, injury or damage or theft;
6. The Hirer hereby indemnifies GDB and its Committee members in relation to any death, injury, loss or damage caused when the equipment is not used in accordance with the regulations of the Club and of the governing bodies of archery in the UK;
7. The Hirer hereby agrees to be responsible for any loss or damage (save for fair wear and tear) caused to any of the equipment whilst it is under their control. In the event of loss or damage to the equipment the GDB Equipment Officer (or other competent member of the GDB Committee) shall determine the cost of repairs or replacement which the Hirer is liable to pay. Fair wear and tear shall also be determined by the GDB Equipment Officer or other competent member of the GDB Committee;

8. If any or all of the equipment is lost or stolen the Hirer hereby agrees to notify GDB immediately the loss becomes apparent and to pay GDB the full reinstatement cost of the missing equipment within 21 days. Any equipment subsequently recovered will be the property of the Hirer. For the guidance of the Hirer the approximate reinstatement costs of the hired equipment as at the date of this agreement is annotated below;
